The applicant must meet the following criteria to apply for the scholarship:

- Is at least 62 years of age prior to the first day of classes for the application term.
- Retirement from gainful employment and not working in a substantially gainful occupation (must provide documentation, i.e., current income tax form).
- Michigan Residency for tuition purposes as defined by the University of Michigan Residency Office.
- Admittance to the University of Michigan-Dearborn as a degree seeking student or as a non-degree student.
- Submission of a letter of intent along with this application.

Additional Information

- You are responsible for the reduced per-credit assessment, the registration assessment, the technology assessment, and any course premiums and laboratory/course fees that may be assessed for specific courses.
- The Retired Persons Scholarship cannot be used by students admitted or enrolled in any web based degree program or any web based graduate course.

Application Information

- Your admissions application, a letter of intent, and an interview will be used to assess your eligibility to receive the scholarship.
 - If you plan to elect credit towards a degree, you must apply and be admitted by a college or school prior to submitting this application for the Retired Persons Scholarship.
 - If you plan to elect courses for enrichment or enjoyment, you must submit the College of Arts, Sciences, and Letters Campus Options Program application along with the scholarship request.
