**DISTRIBUTION REQUIREMENTS**

**ENGLISH COMPOSITION:** (6 hrs.) from ENGL 151 and 152,155, or 254. (Students are required to take an English Composition Placement Exam at UM-Dearborn. For those students who place below the COMP 105 level, COMP 227 will be required).

**ARTS:** (3 hrs.) from ART 280,281,282; MUSIC 265,268.

**LETTERS:** (3 hrs.) from ENGL 240,251,252,253,255,260,267,268; PHIL 152,253.

**FOREIGN LANGUAGE:** (8 hrs. from a 2-course sequence) from FREN, GERMN or SPAN 151,152,251,252. A student may be exempted from the foreign language requirement by demonstrating college-level proficiency in an approved foreign language. Such proficiency may be shown in one of three ways:

1. By presenting three years of high school work in a foreign language with a grade of C or better in the last semester.
2. By passing a written and oral proficiency exam.
3. By completing a one-semester language course at the 102 level or higher in the chosen language with a passing grade.
4. Note that demonstrating proficiency does not grant credit for courses not taken. Students exempt from the foreign language requirement must fulfill the 4-8 credit hours with electives.

**BEHAVIORAL AND SOCIAL SCIENCES:** (9 hrs. with at least one course chosen from each group):  
**Group A:** ANTHR 152,155,165; PSYCH 151,152,153,251,254; SOC 151,152,251,252.  
**Group B:** ECON 251,252,256; POLSC 151,211,221,252.

**HISTORY:** (3 hrs.) from HIST 151,152,153,154,155,158,159,160,255,256.

**MATHEMATICS:** (3/4 hrs.) from MATH 154,157,159,162,164,171,172,251,271,273.

**REQUIRED/RECOMMENDED MATH AND SCIENCE COURSES FOR THE ABOVE MAJORS (see the UM-Dearborn Catalog for specific track requirements)**

**BIOCHEMISTRY:** BIOL 151,153; CHEM 151,152,251,252; MATH 171,172,271; PHY 151,152 or 251,252.

**BIOLOGY:** BIOL 151,153; CHEM 151,152,251,252; MATH 171,172; PHY 151,152 or 251,252.

**CHEMISTRY:** BIOL 151 or 153; CHEM 151,152,251,252; MATH 171,172,271; PHY 251,252.

**EARTH SCIENCE:** BIOL 151,153; CHEM 151,152; ESC 151; GEOG 151; MATH 171,172; PHY 151,152 OR PHY 251,252.

**ENVIRONMENTAL SCIENCE:** BIOL 151,153; CHEM 151,152; ESC 151; GEOG 151; MATH 171,172; PHY 151 or 251.

**MICROBIOLOGY:** BIOL 151,153; CHEM 151,152,251,252; MATH 171,172; PHY 151,152 or 251,252.

**PHYSICS:** CHEM 151,; MATH 171,172,251,271,273; PHY 251,252; (2 other science courses should be chosen from BIOL 151,153, CHEM 153, ESC 151)

The College of Arts, Sciences, and Letters will accept a maximum of 62 credit hours from a community college (grades of C- and below are not accepted). A GPA of 2.5 is currently required. **A maximum of 12 credit hours of transfer coursework in applied art, applied music, and/or music theory can be counted toward the 120 credit hours required for graduation.** It is the student's responsibility to stay in contact with the UM-Dearborn Admissions Counselors to stay abreast of any changes.

**In order to be considered for admission, an application, all required transcripts and documentation, and the application fee if applicable must be submitted to the Office of Admissions and Orientation by the first day of class of your desired term of entry.**

Please be advised that individuals seeking a Provisional Secondary Teacher's Certificate earn their degree from the College of Arts, Sciences, and Letters and should follow its distribution requirements. Currently a gpa of 2.75 is required for a major, a minor, professional courses and overall admission into a Certification Program.

**NOTE:** Teaching majors and minors are highly compatible but not identical to degree requirements in CASL. After transfer, it is important that a student consult with a CASL advisor regarding degree requirements and with a School of Education advisor regarding certification requirements.

“Fingerprinting and criminal background checks are required for work in school settings. Such work is required of all certification students. All background checks must be completed in the first semester of admission to the School of Education.”

By state law, admission to a certification program requires acceptable scores from the Michigan Tests for Teacher Certification (MTTC) Basic Skills Test (reading, writing, mathematics). Each student in a Michigan Teacher Preparation Program must pass the Basic Skills Test before being admitted into a Certification Program.
